## Cookies Policy

Thai Takasago Co., Ltd. “**Company**” values and is committed to protecting the personal data and privacy of visitors to our website. ### Definitions

### What are Cookies

Cookies are small text files stored on your computer or internet-connected device, such as a smartphone or tablet, when you visit the Company’s Website. Typically, cookies record your personal data when you access the Website, such as your name, address, email, password, IP address, phone number, search queries, and user settings (e.g., language preferences). These cookies are then sent back to the Website system for processing or forwarded to other websites that support cookie functionality.

Notwithstanding, Cookies help the Company understand how you use the Website so that we can improve your experience and services to better meet your needs. By saving your cookie settings, the Website can remember your preferences, making future visits more convenient, faster, and responsive to your requirements.

### Types of Cookies Used by the Company

The Company may use the following types of cookies when you visit our Website:

1. Strictly Necessary Cookies
2. Performance Cookies
3. Analytics Cookies
4. Marketing Cookies

### How Does the Company Use Cookies?

The Company collects, uses, or discloses the personal data of Website visitors, including their usage preferences, when they visit the Company’s Website by placing certain cookie files into the visitor’s web browser. In this case, the Company uses cookies for the following purposes:

Type of Cookie	Purpose of Use
Strictly Necessary Cookies	These cookies are essential for enabling visitors to use the Website and its functions, including secure access to information and services. Without these cookies, www.thaitakasago.co.th cannot function properly, and visitors will not be able to use certain services on the Website.
Functional Cookies	These cookies are part of the essential cookies used for the Website's functionality. They are designed to remember visitors and their settings based on usage patterns. This type of cookie helps facilitate future visits, such as remembering usernames and customizing settings according to the visitor's preferences. If you do not allow these cookies, some or all related services may not function optimally.
Analytics Cookies	These cookies are used to process the performance of www.thaitakasago.co.th, helping the Website understand visitor interests. For example, they track the number of visitors, count the pages accessed, and analyze interests and browsing behavior. The Website uses this information to improve its efficiency and enhance the user experience, ensuring the Website meets visitor needs more effectively.
Marketing Cookies	These cookies are used to collect data on Website usage, www.thaitakasago.co.th and the links visitors access or visit. This helps us understand visitor interests and browsing behavior, enabling us to deliver benefits, advertisements, and promotions that are most relevant to their preferences.

### Cookie Settings and Rejection

Website visitors can manage cookies by changing their cookie settings, including accepting, rejecting, or deleting cookies that have been set on the Company's Website. This can be done through browser settings or privacy settings by rejecting all cookies. However, if you choose to reject cookies, certain functions on the Website may not be available, and your browsing experience may be less efficient.

In addition to adjusting privacy settings on your device or browser, visitors can also reject cookies via the pop-up notification on the Website. Please note that if you reject all

cookies, some Website functions may not work properly, and your overall experience may be affected.
